The following subjects have been sanctioned to be introduced at Senior Secondary classes:

- (a) Languages:- English Core, English Elective, Hindi Core, Hindi Elective
- (b) Elective Subjects: History, Political Science, Geography, Chemistry, Biology, Physics, Zoology, Mathematics, Accountancy, Business Studies, Physical Education and Informatics Practice.

The above sanction is subject to fulfillment of following conditions:-

- 1. The affiliation Code Number allotted to your school is <u>531222</u>. This may please be noted and quoted for any further correspondence with the Board.
- 2. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
- 3. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X. As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out from CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level.
